

# Privacy Statement

Effective on January 28, 2011

GAMMS UNLIMITED is committed to protecting your privacy. This privacy statement describes how GAMMS UNLIMITED collects and uses the personal information you provide on our website: [gammsunlimited.com](http://gammsunlimited.com) it also describes the choices available to you regarding GAMMS UNLIMITED use of your personal information and the steps you can take to access this information and to request that we correct or update it.

## Collection and Use of Personal Information

We may collect the following personal information from you.

For example, we may share personal information with our agents or service providers to send you email on our behalf. These third parties are authorized to use your personal information *only* to perform the service they are providing for us.

We reserve the right to disclose your personal information as required by law (e.g., to comply with a subpoena, warrant, court order, or legal process served on our website) and when we believe that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, and/or respond to a government request.

In the event GAMMS UNLIMITED goes through a business transition, such as a merger, acquisition by another company, or sale of all or a portion of its assets, your personally identifiable information will likely be among the assets transferred. You will be notified via email and/or a prominent notice on our website of any such change in ownership or control of your personal information, as well as any choices you may have regarding your personal information.

## **Cookies and Other Tracking Technologies**

### *Cookies*

Cookies are very small text files that are stored on your computer when you visit certain web pages. We or third parties may use cookies on our site to

- Compile aggregate statistics about our site visitors
- Analyze which pages our site visitors visit
- Measure advertising and promotional effectiveness
- Make it easier for you to navigate our site

### *Log Files*

As is true of most websites, we gather certain information automatically and store it in log files. This information may include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and/or page views.

We may use this information, which does not usually identify individual users, to analyze trends, to administer the site, to track users' movements around the site and to gather demographic information about our user base as a whole.

### *Web Beacons*

A web beacon is an electronic image placed on a web page that can serve many of the same purposes that cookies serve, for example, recording the pages you visit on our site. We or third parties such may use web beacons to track the traffic patterns of users from one page to another.

We or our third party service provider may use web beacons in some of our emails to let us know which emails have been opened by recipients or track click-through rates. This allows us to gauge the effectiveness of our communications to customers and our marketing campaigns.
